#### WARNING REGARDING UNTRUTHFULNESS

**Note:** LTC & FID Application **Question #4** reads as follows: "Have you ever been arrested or appeared in court as a defendant for any criminal offense?"

The key word is "appeared". Having been charged and convicted of a crime does not necessarily prohibit you from getting an FID or LTC. **Not answering truthfully does.** 

Understand that "appeared" includes all adult and juvenile appearances. It does not matter if you were found not guilty, or if the charges were dismissed, or if you received a continuance without a finding, or your record was sealed--you still have to answer "yes" to the question if you ever appeared as a defendant in any court for any criminal offense. If you do not answer truthfully, we will find out, no matter how long ago.

If you have a **sealed record**, you also have to indicate this; we are notified of disqualifiers even if they are from a sealed record.

We will not accept "I forgot," "They told me it would not show up," or "It never showed up before." Remember: you are signing this application under penalties of perjury; you will be denied a license for any untruthful answer and you may face the possibility of prosecution.
