Firearms Licensing Process

You must schedule an appointment by first telephoning the police department at 508-763-4017 and asking to speak with the firearms licensing officer.

On the date of the appointment, you are required to bring a completed application and all required documentation. Applications will only be accepted during your appointment. Incomplete or partial applications will not be accepted.

If this is the <u>first-time</u> you are applying to the Freetown Police Department for a License to Carry (LTC) Firearms, you will need to bring the following together with your application:

- Two (2) items of personal identification. For example, your Massachusetts driver's license or identification card, a certified copy of a birth certificate, or a U.S. Passport.
- Two (2) items to verify residency at the time of their appointment. These items will have the applicant's name and address, such as your Massachusetts driver's license or identification card, tax bill, voter registration, phone bill or utility bill.
- A copy of your Massachusetts approved firearms-training or hunter safety course certificate (however, current members of the U.S. military or Mass. National Guard are not required to submit a certificate).
- Two notarized letters of reference. They must be signed and notarized and include the name, address and phone number of the person giving the reference, and the length of time the reference has known you.
- For naturalized citizens, a copy of your Naturalization documentation.
- For resident aliens, a visa, or identification card ("green card") containing the alien registration number, attesting to your permanent resident status as an alien in the United States.
- For business owners who do not reside in town, a letter that includes the date on which you applied for a license
 within your home community, the name of the police department that the application was submitted to, and the
 reason for denial.
- A non-refundable application fee of \$100, check or money (no cash), made payable to the Town of Freetown. An application fee of \$25 is applicable to retired law enforcement officers and officers from another agency.
- A letter stating the reason(s) why you are requesting a LTC. See license restrictions.

Licenses to Carry (LTC) are issued with the following restrictions:

Not an all-inclusive list.

- Hunting and target
- Sporting
- Employment
- None (All Lawful Purposes) You must demonstrate a need for an un-restricted LTC in your letter. Your letter must:
 - o specify the actual fear for your person and/or property. See M.G.L. c. 140, § 131(d). Generalized fear of potential crimes against the person is not sufficient; or
 - o identify your employment as a law enforcement officer; or
 - o be on company letterhead identifying your employment as security officer, guard, detective or investigator. This class of license will be restricted to employment and in traveling to and from it. You must notify the licensing authority upon termination of such employment and the license will be void forthwith.

If this is the <u>first time</u> you are applying for a Firearms Identification Card (FID) you will need to bring with you:

- Two (2) items of personal identification. For example, your Massachusetts driver's license or identification card, a certified copy of a birth certificate, or a U.S. Passport.
- Two (2) items to verify residency at the time of their appointment. These items will have the applicant's name and address, such as your Massachusetts driver's license or identification card, tax bill, voter registration, phone bill or utility bill.
- A copy of your Massachusetts approved firearms-training or hunter safety course certificate (however, current members of the U.S. military or Mass. National Guard are not required to submit a certificate).
- For naturalized citizens, a copy of your Naturalization documentation.

- For resident aliens, a visa, or identification card ("green card") containing the alien registration number, attesting to your permanent resident status as an alien in the United States.
- For business owners who do not reside in town, a letter that includes the date on which you applied for an FID within your home community, the name of the police department that the application was submitted to, and the reason for denial
- A non-refundable application fee of \$100 check or money (no cash), made payable to the Town of Freetown. An application fee of \$25 is applicable to persons under 18 years of age.
- If the applicant is between the ages of 15 and 18 years, an authorization letter signed by the parent or quardian.

To <u>renew</u> your License to Carry (LTC) Firearms or Firearms Identification (FID) Card you will need to bring with you:

- Your Massachusetts driver's license or identification card or, if you do not have one, a certified copy of your birth certificate, or a U.S. Passport.
- A non-refundable application fee of \$100, check or money (no cash), made payable to the Town of Freetown. An
 application fee of \$25 is applicable to retired law enforcement officers and officers from another agency, and \$25 for
 persons under 18 years of age. There is no renewal fee for a person over 70 years of age.
- If you do not have an unrestricted license and are requesting one, you must submit a letter as described above in the "Licenses are issued with the following restrictions" section.

Note:

LTC & FID Application **Question #10** reads as follows: "Have you ever **appeared** in **any** criminal court as a defendant for **any** criminal offense or criminal traffic offense (excluding non-criminal traffic offenses)?"

The key word is "appeared" rather than "arrested." Having been charged and convicted of a crime does not necessarily prohibit you from getting an FID or LTC. Not answering the question truthfully does.

Understand that "ever appeared" includes **all adult <u>and juvenile appearances</u>**. It does not matter if you were found not guilty, or if the charges were dismissed, or if you received a continuance without a finding, or your record was sealed - you still have to answer "yes" to the question if you ever appeared in any criminal court. If you do not answer truthfully, we will find out, no matter how long ago you appeared in court.

If you have a **sealed record**, you also have to indicate this; we are notified of disqualifiers even if they are from a sealed record.

We will not accept "I forgot," "They told me it would not show up," or "It never showed up before." Remember: you are signing this application under penalties of perjury; you will be denied a license for any untruthful answer and you may face the possibility of prosecution.
