ADDITIONAL TERMS & CONDITIONS

The Permit is issued pursuant to Mass. General Laws Chapter 90, Section 19, and is valid only if used in compliance with Mass. General Laws and Regulations, and the Permit is subject to the following conditions:

1. The Permit relates to Town of Freetown public ways only;
2. The Permit covers properly registered vehicles and trailers only;
3. The Permit, or a true photocopy thereof, shall be kept with the moving load at all times;
4. The Permit is valid only during daylight hours (sunrise to sunset);
5. The Freetown Police Department shall be notified by telephone (508-763-4017) of the date(s) and hour(s) of operation and route of travel;
6. The load shall be firmly chained to the truck, trailer or semi-trailer in accordance with all applicable laws and regulations;
7. All loads exceeding a width of 8'– 06" shall have red fluorescent warning flags affixed to all extremities of the load, and each flag must be at least 12" square;

8. A sign labeled "Wide Load" shall be affixed to the front of the vehicle, letters to be a minimum of 6" high block;
9. Escort vehicles are required as follows:
 - a. One escort required for vehicles with lengths of 85' to 95' feet (to be located behind oversized vehicle), and two (2) escorts for vehicles exceeding 95' in length
 - b. one escort required for vehicles with widths of 12' to 13' - 6" (to be located behind the over-width vehicle), and two (2) escorts for vehicles exceeding 13' - 6" in length
 - c. Two escorts required for dozers over 12' wide with blade attached;
10. Permit Limits: Width: 14' Height: 14' Length: 115' ; and
11. A route survey is required for height exceeding 13'-8"

THE PERMIT MAY BE SUSPENDED OR REVOKED FOR VIOLATION OF ANY OF ITS TERMS AND/OR CONDITIONS.
