License to Carry Firearms (LTC) and Firearm Identification Card (FID) applications include **Question #4** which reads as follows: "Have you ever been arrested or appeared in court as a defendant for any criminal offense?"

The key word is **"appeared"**. Having been charged and convicted of a crime does not necessarily prohibit you from getting an LTC or FID. However, **not answering truthfully will**.

Understand that "appeared" includes **all adult and juvenile appearances.** It does not matter if you were found not guilty, or if the charges were dismissed, or if you received a continuance without a finding (CWOF), or your record was sealed – you still have to answer "yes" to the question if you ever appeared in any criminal court.

If you have a **sealed record**, you also have to indicate this; we are notified of disqualifiers even if they are from a sealed record.

If you do not answer truthfully, we will find out.

Examples of unacceptable answers include: "I forgot," "They told me it would not show up," and "It never showed up before." Remember: you are signing this application under penalties of perjury; you will be denied a license for any untruthful answer and you may face the possibility of prosecution.
